1. These terms and conditions for the use of the adventure park (hereinafter: adventure park) (hereinafter: terms and conditions) determine the rights, obligations of the adventure park operator Haapsalu Seikluspark OÜ (registration code: 14814491) and the visitor to the adventure park (hereinafter: client) and the liability to the client arising from the use of the adventure trails of the adventure park (hereinafter: adventure trail).
2. The terms and conditions apply to all clients who use the adventure trail.
3. When using the adventure trail, the client is obliged to comply with all requirements (hereinafter: requirements) and conditions, additional instructions and orders of the employees of Haapsalu Seikluspark OÜ, as well as instructions and markings on the adventure trail.
4. The client undertakes to pay for the use of the adventure trail before using the adventure trail according to the current price list of Haapsalu Seikluspark OÜ.
5. The client is aware that using the adventure park may damage the client's clothes and accompanying items and may be dangerous to life and health if the client does not strictly follow all safety and security requirements, the instructions of Haapsalu Seikluspark OÜ employees and the requirements set out in the terms and conditions. The client uses the adventure park at his own risk (liability) and Haapsalu Seikluspark OÜ is not liable for any possible damage caused to the client due to non-compliance with the requirements (including damage to property and health), if the client has violated the requirements intentionally, wrongfully or due to gross negligence.
6. Haapsalu Seikluspark OÜ is not liable for the loss, damage or destruction of the client's clothes and other items.
7. The client may not use the adventure trail before he has received instructions and safety equipment from a Haapsalu Seikluspark OÜ employee for the safe use of the adventure trail. Before using the adventure trail, the client must make sure that the selected adventure trail meets his physical abilities, health condition and skills.
8. It is prohibited to use the adventure trail without safety equipment attached to the safety rope. This is dangerous to life and health.
9. It is prohibited to use the adventure trail while intoxicated by alcohol, narcotics and/or psychotropic substances, and to use these substances in the adventure park. It is prohibited to make a fire in the territory of the adventure park and to smoke on the adventure trail.
10. It is prohibited to pass on the safety equipment to another person. After completing the trails (after using the children's park), the safety equipment must be returned immediately to Haapsalu Seikluspark OÜ. The client is obliged to use the adventure trail and safety equipment carefully and not to break or otherwise damage them. The client is obliged to compensate Haapsalu Seikluspark OÜ for all damage caused to the adventure trail and/or safety equipment due to the client's negligent or intentional behavior.
11. An employee of Haapsalu Seikluspark OÜ has the right to immediately remove the client from the adventure trail if the client violates the requirements and/or conditions, does not comply with the orders of an employee of Haapsalu Seikluspark OÜ, or if, in the opinion of an employee of Haapsalu Seikluspark OÜ, it is no longer safe to use the adventure trail. If the client's well-being deteriorates or the weather conditions change, making it no longer safe to use the adventure trail, the client must leave the adventure trail immediately, following the safety rules.
12. The fee paid to Haapsalu Seikluspark OÜ for the use of the adventure trail will be refunded to the client only if the use of the adventure trail is not possible due to circumstances arising from Haapsalu Seikluspark OÜ. In the case of the conditions specified in point 11, the fee paid to the client will not be refunded.

REMINDER FOR USERS OF Haapsalu Seikluspark OÜ SERVICES: ADVENTURE TRAIL SAFETY

- Adventure park customers are received by trained personnel (instructors).
- Appropriate and compliant safety equipment is used when providing the service.
- Children and adolescents are instructed in a way that they understand.
- During the instruction, the rules for using the adventure trail are introduced, i.e., they are explained and shown step by step how to safely pass the adventure trail.
- All customers are required to pass a learning trail, where the instructor monitors whether the customer has understood the safety rules.
- The instructor is constantly within sight or hearing distance and, if necessary, assists the customer from the ground or in a tree.
